# 7. Opening Remarks

Sister Baldwin provided a bargaining update.

Dec 6<sup>th</sup> is the National Day of Action and Remembrance on violence against women. This year marks the 25<sup>th</sup> anniversary of the Montreal Massacre. The YWCA has promoted the rose campaign <a href="https://www.rosecampaign">www.rosecampaign</a> Together we need to send the message that this violence is NOT OKAY, we are urging brothers to be part of this – #notokay.

PSAC is launching a domestic violence in the workplace survey. This information will be released on December 6<sup>th</sup>.

Sister Baldwin advised that the Leadership Training is scheduled Jan 23-24, 2014 in Halifax, NS.

The CLC will be putting on a Federal Election Conference between January and March 2015.

# **Guest Speaker, Tony Tracy, CLC**

Brother Tracy attended the meeting as guest and discussed the following:

- Sister Baldwin's role on the CLC Canadian Council
- Provided an overview of the CLC's current campaign "Together Fairness Works" which is about having face to face discussion with members.
- The CLC will be hosting Election Prep Conference in the Atlantic Provinces.
- Very active with their retirement security campaign and its' re-launching. Essentially the campaign is comprised of 3 components, which are: 1. To ensure our pension funds are going to be there for us after we retire. 2. The need to raise the GIS to raise the seniors' level of income. 3. CPP needs to double, this could happen through phasing in the doubling of employer payments and workers would need to contribute as well.
- Bill C-377 financial disclosure bill which should have died some time ago, is back in senate again in its original forum. Brother Tracy urges activists to lobby senators on this and encourage them to vote against the bill.

## **Guest Speaker, Jeff Callaghan, CUPW**

Spoke about sick leave. CUPW concession bargained and ending up losing their sick leave, being replaced with 7 personal days. If over and above the personal days, you would be off without pay, waiting to see if our short term disability has been approved. Workers are going to work sick as there is no other choice.

Brother Callaghan spoke about cuts to the postal service: Door-to-door mail delivery will be eliminated and the effects this has on the community, elderly, persons with disabilities etc. Consequently there will be an increase in stamp prices and many public post offices will be closing.

- 3. A proposal to be drafted by the PSAC Atlantic Regional office to expand the EI Strategic Campaign to other conservative ridings such as Miramichi, Edmundston and Summerside.
  - Such a proposal would be apprx. \$10k which would have to be approved by the National Level. The target ridings have yet to be identified.

#### 12. Finance Policies & Procedures

Sister Murphy-Langille provided an overview of the recent changes implemented by the finance branch; such as:

- Member Expense Claim Portal (MEP) which is the online transmittal of processing member expense claims.
- Recent changes to the family care and travel policy.

Sebastien provided overview for the EI strategic campaign and the 3 digital billboards in NB.

We will identify targeted areas for EI, veterans etc. and place billboards accordingly.

# Organizing DCL's

Brother Oldford asked the REVP if we have halted organizing DCL's in NB.

Sister Baldwin provided the following explanation in regard to the organizing process:

In the Atlantic Region, the Regional Organizer submits an organizing plan to the Co-ordinator and REVP. The organization plan must reflect the PSAC Organizing Guidelines (attached as appendix A), our target sectors and that we are able to provide service to the workers that we organize.

At this moment we have requested from the organizer, to suspend any new organizing in New Brunswick unless they are self- servicing or interested in being part of a component.

We have approx. 6500 members, 67 locals and two staff members in the Moncton RO who provide service in both languages.

PSAC is at a stage that we cannot organize any more workers in New Brunswick unless they are self-servicing, if we do we will not be able to provide the support and service to our current members.

# **Round Table**

Directors had the opportunity to provide an update on the activities they have been involved with since the last Council Meeting in October.

Sister Hardy provided a summarized update on bargaining:

UTE has been without a Collective Agreement for 2 yrs. Once a deal is reached, it is only valid for 2 years and the bargaining process will start all over again. She advised that members will

hold on to their severance and refuse to let it go. UTE is waiting on the PIC report and recommendation and hoping to discuss these recommendations of the report early in 2015.

Sister Manuel-Allain, USGE advised that they are presently working on a campaign from a public safety perspective and the results of the effects the cuts have on the prison (staff specifically). Prison cuts mean less staff which impacts their work negatively and as a result affects public safety.
